14 DAYS TO FILE

This article is for informational purposes. Many people believe the union has 14 days from when we receive notice from the employee to file a grievance. This is simply not true. What the contract states is, "...must discuss the grievance with the employee's immediate supervisor within fourteen (14) days of the date on which the employee or the Union first learned or may reasonably have been expected to have learned of its cause."

Based on the language in our Agreement, the 14 day period to file a grievance begins when the employee <u>or</u> the union became aware of the allege violation. If the employee receives a disciplinary action on June 1, that starts the clock ticking. If the employee then hands the discipline to the union on June 20, we now have to have a legitimate explanation as to why the grievance was not filed within 14 days.

In essence, a new hurdle to jump. In cases such as this, before we can even address the merits of the grievance, we have to prove it was timely filed. If a grievance is not timely filed, the contract states that the union is deemed to have "waived" the grievance.
