# **JEREMY BARRIAULT MEMORIAL SCHOLARSHIP AWARD**

Brother Jeremy Barriault was a devoted, and dedicated union representative for Local 321. As a staunch advocate of higher education and improving one's position in life, Brother Jeremy represented all that is true within the Labor Movement. Local 321 of the NPMHU honors Brother Jeremy Barriault by keeping his name and visions alive through our scholarship program.

## **MISSION STATEMENT**

The Executive Board of Local 321 has committed twenty-five hundred dollars (\$2,500.00) to be awarded equally to five (5) eligible applicants with five (5) five hundred-dollar (\$500.00) scholarships for the 2026-2027 school year. Local 321 is offering these scholarships to help offset the financial burden for those members of Local 321 and those dependents of members of Local 321 who desire to better themselves through higher education as a full-time student.

## **RULES AND ELIGIBILITY**

The aforementioned scholarships will be awarded through a random drawing. To have an application entered into the drawing, the applicant must adhere to the rules as stated below:

1. Local 321's scholarship program is open to all members, spouses of members, and legal dependents of members of Local 321 of the National Postal Mail Handlers Union. Other family members are not eligible. To be eligible for the scholarship drawing, the member must have been a regular -dues-paying member in good standing, as defined by the Constitution of the National Postal Mail Handlers Union, during the eighteen-month period prior to January 31, 2026.
2. Applicants must have graduated or received a high school equivalency diploma (or will graduate or receive a high school equivalency diploma during the final semester of the 2026-2027 school year). Proof of high school graduation, impending graduation, or the equivalent will be required before the scholarship application is entered into the drawing.
3. Applicants must plan on attending an accredited institution of higher learning (i.e., a two-year or four-year college or an accredited vocational institution) during the 2026-2027 school year and must be registered as full-time students.
4. Only one application per eligible individual is allowed. Submission of duplicate applications will result in disqualification of that specific individual. An application from more than one eligible individual from the same family is permitted.
5. Applicants must fill out the application form in its entirety. Partially completed forms will not be entered into the drawing.

6. **No single applicant may receive more than two (2) five hundred-dollar (\$500.00) Jeremy Barriault Memorial scholarships during their lifetime. Any applicant having previously received two scholarships from Local 321 will be disqualified.**
7. Applications will be available at Local 321 Union Hall, 1833 W Elk PL, Denver, CO 80211. Applications will also be made available at the various Mail Handlers Union offices in the states of Wyoming / Colorado and online at <https://www.npmhulocal321.org>
8. Applications must be completed and **received at the designated Post Office Box only by Monday, April 27, 2026, at 10 AM. Any lost applications, late applications, applications received at any other address, or applications submitted through any other means will not be qualified for entry into the drawing.**
9. The designated Scholarship Committee will open the Post Office box on Monday, April 27, 2026, at 10 AM, and the contents will be taken to the Local union hall.
10. If five (5) or fewer applications are received, all applications determined eligible by the Scholarship Committee will be automatically awarded a five hundred dollar (\$500.00) scholarship, and the need for a drawing will be declared a moot issue.
11. If more than five (5) applications are received, the Scholarship Committee will verify the eligibility of each applicant. If more than five (5) applicants are eligible, each eligible applicant will have his/her name placed in a drawing. The drawing date is to be determined by the Scholarship Committee. Each name will be randomly placed into a container. The Chairperson of the Scholarship Committee (or his/her designee) will randomly pull five names from the container who will be declared scholarship winners. The drawing will be conducted at the Local union hall and will be open to any interested members of Local 321 and any applicant.
12. Each of the five (5) applicants whose names are pulled from the container will be awarded a Promissory Note designating one Five Hundred dollar (\$500.00) scholarship to be applied to any two or four-year college or accredited trade school of the applicant's choice.
13. If an applicant later chooses not to attend an institute of higher learning or accredited trade school, the scholarship will be forfeited. No other drawing or selection will be made from a forfeited scholarship.
14. The Executive Board of Local 321 reserves the right to amend, disband, or otherwise alter this scholarship program as it deems necessary.
15. The Scholarship Committee is not eligible to participate or to sponsor candidates for this program.
